- The Pune Cantonment Board hereby allows M. A. Rangoonwala, College Of Physiotherapy and Research to make use of Sardar Vallabhbhai Patel Cantonment Hospital during working hours of the Hospital for clinical experience to impart practical training to Students of Final Year, Post Graduate Students, and Interns. Maximum 10 students at a time.
- Strength of the courses is as under: The present strength of the Courses - Bachelor of Physiotherapy (UG) Course is
   210 students and Master of Physiotheapy (MPTH) is 04students.
- 3. The Cantonment will not pay any remuneration to M. A. Rangoonwala, College Of Physiotherapy and Research Students on this account.
- 4. M. A. Rangoonwala, College of Physiotherapy and Research will not claim any type of fund or grant from the Pune Cantonment Board for this educational activity.
- 5. In consideration for the facility of practical training made available, M. A. Rangoonwala, College Of Physiotherapy and Research will pay the remuneration to the Pune Cantonment Board.
- 6. The party of the second part has agreed to pay remuneration as per rate prescribed by the Govt. of Maharashtra i. e. per day per bed at Rs.10/- for each student by the said institute & any charges applicable by state Govt. from time to time. Remuneration will be deposited with Pune Cantonment Board on the 15<sup>th</sup> of every month.
- 7. M. A. Rangoonwala, College Of Physiotherapy and Research will pay security deposit of Rs.1 Lakh in the form of online payment through e-chawani portal. - 10.M. A. Rangoonwala, College Of Physiotherapy and Research has to ensure the the students attend the hospital regularly and in time for the duty hours.
- 11.Clinical training of Students should not cause any disturbance in the routin functioning of the Hospital.
- 12. This agreement is valid for a period of one year from date of this agreement and renewable every year subject to the overall performance of the execution of the terms and conditions of the MOU at the option of the party of the first part i. e Pune Cantonment Board.
